# Medical Drug Update for Rituximab Biosimilars (Truxima, Ruxience) - Commercial Products

Blue Cross and Blue Shield of Minnesota and Blue Plus (Blue Cross) is clarifying prior authorization (PA) requirements for rituximab. Blue Cross does **not** require PA of rituximab biosimilars (Truxima, Ruxience) for non-oncologic indications for commercial lines of business.
