Extended care and halfway house room and board submission

We are advising providers as promptly as possible that effective July 1, 2008, Blue Plus is responsible for reimbursing providers for extended care and halfway house services for our Minnesota Health Care Program members. This applies only to the government programs listed below.

To ensure that Blue Plus can accurately distinguish, adjudicate the claim and report encounter data to the Minnesota Department of Human Services (DHS), the room and board (R&B) charges for extended care, halfway house and primary residential treatment, must be submitted in the following manner:

Provider type	Type of bill	R & B revenue code	R & B revenue code description
Primary residential	086X	1002	Behavioral health accommodation – residential treatment – chemical dependency
Extended care	086X	1003	Behavioral health accommodation – supervised living
Halfway house	086X	1004	Behavioral health accommodation – halfway house

Treatment

Treatment should also be reported in addition to the appropriate R&B codes noted above. Chemical dependency treatment is reported using either revenue code 0944 (Drug rehabilitation) or 0945 (Alcohol rehabilitation).
