Update on chemical dependency halfway house and extended care services notification process

On July 28, 2008, Provider Bulletin P16-08 was issued advising providers that effective July 1, 2008, Blue Plus is responsible for reimbursing providers for extended care and halfway house services for our Minnesota Health Care Programs members. *This applies only to the government programs groups listed on the following page*.

Process to report services

This Quick Points provides updated information on the process to report services provided to affected members and the information that is needed by Blue Plus.

A new form has been created and an updated fax number is provided to streamline the notification process.

Admission notification

For Blue Plus members in the affected groups, please notify Blue Plus of the member's extended care or halfway house services by faxing a copy of the following forms to (651) 662-0854:

- Chemical Dependency Notification of Residential Admission Form
- Rule 25 Assessment and Placement Summary

The Chemical Dependency Notification of Residential Admission Form is available at **bluecrossmn.com.** Blue Plus will notify you that the information has been received.

Discharge notification

Please notify Blue Plus of a discharge from extended care or halfway house services by calling (651) 662-5270 or 1-800-528-0934; prompts will direct you to the correct option to leave the discharge date. You may also fax discharge information to (651) 662-3314. When reporting a discharge, please provide the following information:

- Member name and ID #
- Blue Plus case number provided by Blue Plus
- Provider name, contact name and contact phone number
- Discharge date
