# Addition of Drug to the Vesicular Monoamine Transporter 2 Inhibitors (VMAT2) Prior Authorization with Quantity Limit Program

Effective August 1, 2017, Blue Cross and Blue Shield of Minnesota and Blue Plus (Blue Cross) will be adding a prior authorization (PA) with quantity limit (QL) requirement for the following product. Please note that the Xenazine (tetrabenazine) PA with QL program has been renamed to Vesicular monoamine transporter 2 inhibitors (VMAT2) PA with QL.

## CoverMyMeds prior authorization request service

As a reminder, CoverMyMeds (CMM) is a free service to providers which allows quick and easy submission of PA requests. Experience with CMM by other plans has demonstrated marked reductions in physician office call-backs regarding PA requests, after CMM is implemented. PA requests may also continue to be faxed to their review destination external to the CMM portal, as is the current practice.
