New Pre-Authorization Forms for Bariatric Surgery, Lumbar Fusion and Percutaneous Facet Joint Denervation

As previously announced in "Prior Authorization/Pre – Approval Forms Specific to Select Medical Policies" (QP12-17), the following three pre-authorization forms will be available on August 11, 2017:

- Bariatric Surgery (Medical Policy IV-19)
- Spinal Fusion: Lumbar (Medical Policy IV-87)
- Percutaneous Facet Joint Denervation (Medical Policy IV-95)

All three forms may be used for commercial lines of business. The Percutaneous Facet Joint Denervation form may also be used for Government Programs products: SecureBlue (MSHO), Prepaid Medical Assistance Program (PMAP), MinnesotaCare and Minnesota Senior Care Plus (MSC+).

Pre-Authorization requests for Bariatric Surgery, Spinal Fusion: Lumbar or Percutaneous Facet Joint Denervation that do not use these specific pre-authorization forms will not be denied because one of these forms was not completed and submitted for the pre-authorization. However, the intent of the creation of these specific pre-authorization forms is to reduce the number of pre-authorization denials for incomplete or incorrect information and to reduce the amount of interaction needed between Blue Cross and the provider in order to identify all the clinical information needed for the most appropriate outcome for both the provider and the subscriber.
