This plan has a non-embedded deductible . If you have other family members on the plan , the overall family deductible must be met before the plan begins to pay. The single deductible applies to single coverage only.
Are there services covered before you meet your deductible?	Yes. Well child care, prenatal care and in-network preventive care services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible .
