<b>What is the overall <a href="#">deductible</a>?</b>	\$3,750 individual / \$11,250 family <a href="#">in-network</a> \$20,000 individual / \$40,000 family <a href="#">out-of-network</a>	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. This <a href="#">plan</a> has an embedded <a href="#">deductible</a> .
