What is the overall <u>deductible</u> ?	\$2,000 individual / \$6,000 family <u>in-</u> <u>network</u> \$20,000 individual / \$40,000 family <u>out-of-network</u>	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. This <u>plan</u> has an embedded <u>deductible</u> . If you have other family members on the <u>plan</u> , each family member must meet their own individual deductible until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Well child, prenatal care, and <u>in-network preventive care</u> services are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	\$7,500 individual / \$15,000 family <u>in-network</u> Not applicable; there is no <u>out-of-</u> <u>network</u> limit.
