What is the overall deductible?	\$3,750 individual / \$11,250 family in-network \$20,000 individual / \$40,000 family out-of-network	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. This <u>plan</u> has an embedded <u>deductible</u> .
